- The Application form for Enrolments should be handed in to the college administrator or e-mailed to the college administrator at [apply2023@revivalcitycollege.co.za](mailto:apply2023@revivalcitycollege.co.za) along with all supporting documentation. Please ensure that no documents or information is left out. When emailing please note: SUBJECT LINE = LEARNER NAME & SURNAME GRADE 2023 e.g. **Joe Soap Grade4** (*NOTE NO SPACE BETWEEN GRADE AND NUMERAL*)
- **The non-refundable registration fee of R 1 000.00 is due for Grade R-7 and R 1 500 for Grade 8-9 on submission of the Application Form with all the supporting Documents.**
- Once the Application and all supporting documents have been received, your child will be scheduled to write a Baseline Assessment Test. Once these results have been analyzed, you will be contacted as to the status of your application – Whether your child is accepted or not.
- On acceptance of your child's application your agreement to pay College fees and the Method of Payment document will be processed and you will receive an acceptance letter.
- The first month's College fee for 2023 of R3 000.00 must be paid by 3<sup>rd</sup> of December 2022 and the 2<sup>nd</sup> payment by 3<sup>rd</sup> January 2023 in order for your child's enrolment to be finalized and for your child's placement into our college to be secured.
- **Please note that College fees are paid two (2) months in advance and must be received by the 3<sup>rd</sup> of each month. Revival City College reserves the right to charge interest of 15% p.a. on all accounts which may be in arrears of 30 days.**
- The College fees for all enrolments will be R 3 000.00 per pupil per month for 12 months.
- Should your child leave Revival City College one calendar month's notice is to be given.
- In the event of breach of contract, where the undersigned parent/s or legal guardian fail to meet their financial obligations, enrolment at the college will be terminated, legal steps may be taken to recoup the outstanding school fees.
- The account holder acknowledges that the school has the right to hand over their personal details to the necessary bodies in order to recoup outstanding school fees.
- The account holder acknowledges that the College will conduct an ITC check before enrolment of learners.
- Payments of the re-registration fee can be made via EFT or via the Ikhokha Card on or before the 3<sup>rd</sup> of August.

***School fees are compulsory at Revival City College and no exemption may be applied for.***
